- 11 The teacher performs his/her duties specified under section 24(1) of the Act; and
- 12 The teacher performs shall not engage himself of herself for private teaching activities.
- 13 The School shall follow the syllabus on the basis of curriculum laid down by academic authority under sub-section (1) of section 29.
- 14 The School shall Enrol students proportionate to the facilities available in the school specified the section 19 of the Act.
- 15 The School shall maintain the standards and norms as specified in section 19 of the Act. The facilities reported at the time of last inspection are as given under ;
